DGT in figures

- Directorate-General for Translation (DGT) is the Commission's internal LSP
- 24 Language Departments. 1300 translators (Danish language: 55 translators and 8 assistants (Luxembourg/Brussels))
- Translation of legislative documents (50 %), reports, communication and web content into mother tongue
- Translates between 2.3 and 3 mio. pages/year
- Outsourcing (approx. 38 %)

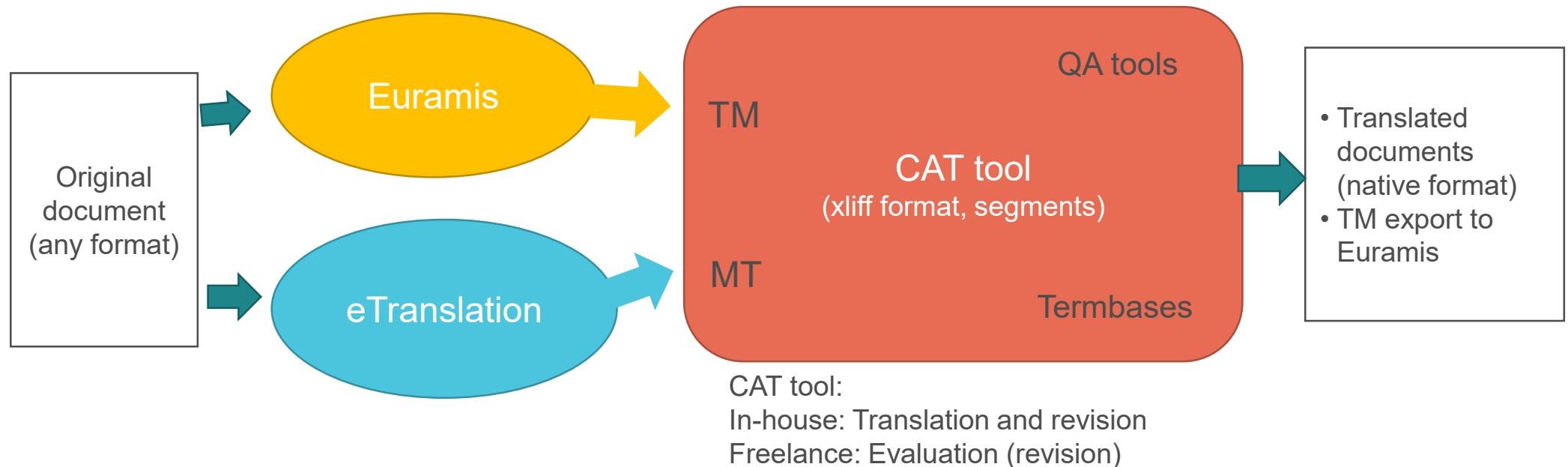

Machine translation at the EU – past and present

- Systran (rule based). Low quality and language coverage
- MT@EC (2012-2018): Statistical machine translation
- eTranslation (2018 >): Neural machine translation
- AI (new): Quality estimation/language recognition/summarisation/anonymisation/classification (Eurovoc)

Our workflow: Language technology tools

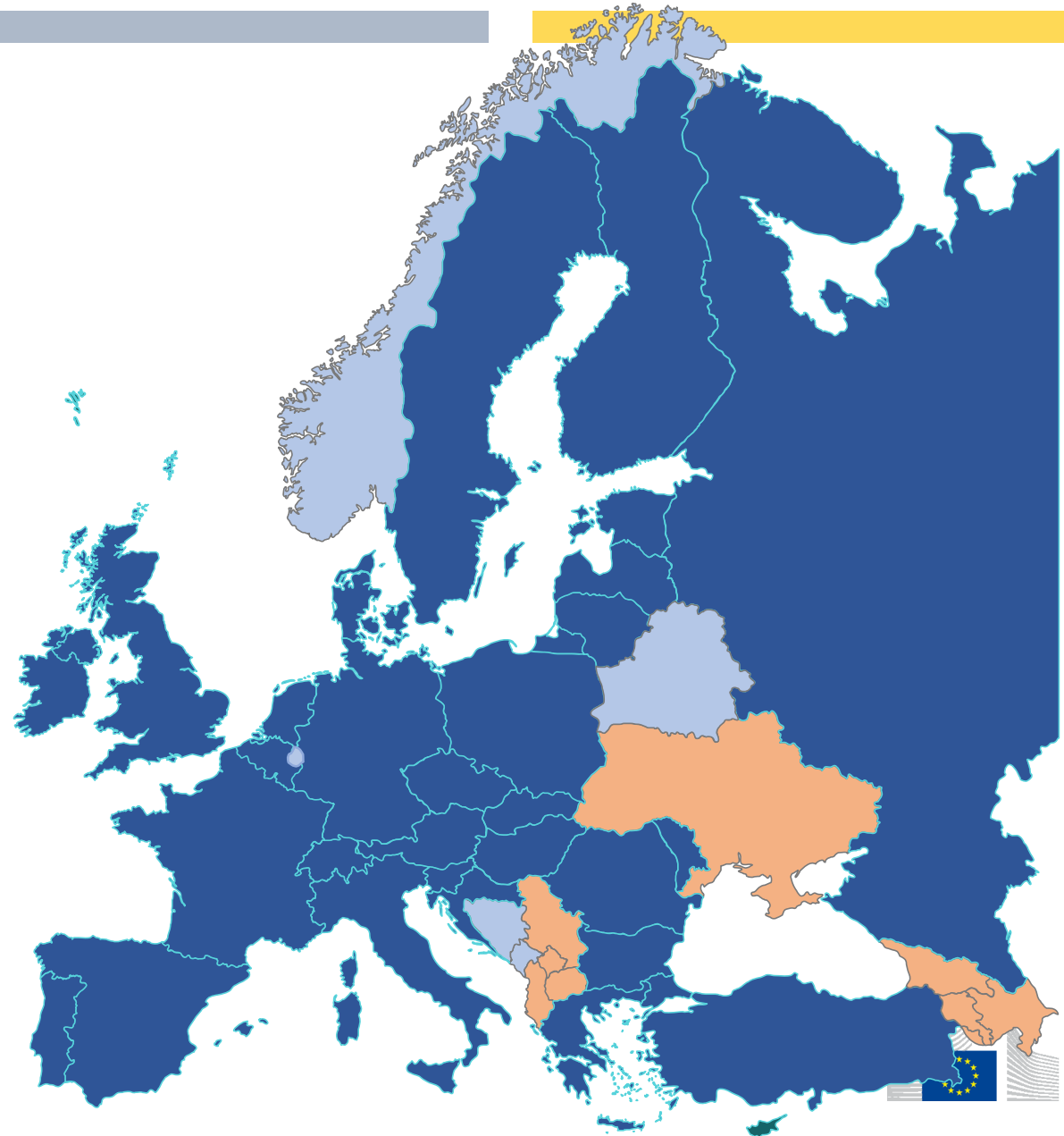
- Translation memories (TM) and machine translation (MT) are retrieved automatically for each translation project

Important facts about eTranslation

- All official EU languages (plus Norwegian, Icelandic, Russian, Chinese, Japanese, Turkish, Arabic)
- Neural machine translation trained with (mostly) own data
- > 185 million translated pages (2021)
- 250 million requests (2020)
- Developed by DGT, but available to all European public administrations, SMEs, freelance translators and universities



NMT pitfalls – What to keep an eye on

- At first glance, sentences translated with NMT look convincing (fluency/syntax)
- However, semantics and terminology must be checked
- Typical mistakes:
 - inconsistent terminology
 - meaning (wrong/inaccurate)
 - omissions/additions
 - negations (omitted or added)
 - made-up words

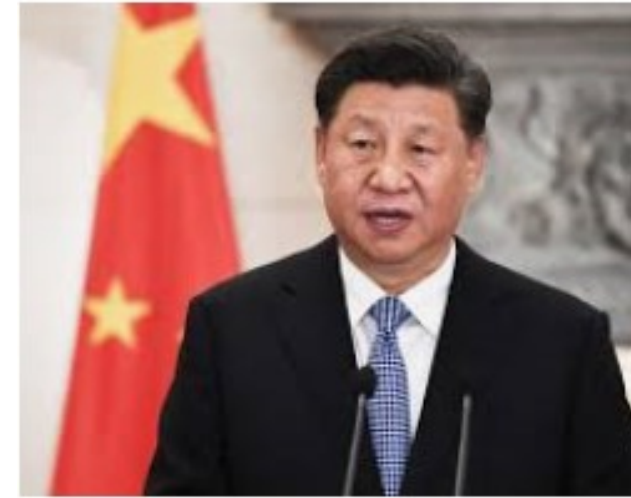

- Facebook: Xi Jinping -> ‘Mr. Shithole’ (burmesisk-engelsk)
- EU-tekst: Kalkun i stedet for Tyrkiet (‘Turkey Gate’)

Training neural MT engines

- All systems use similar software
- Quality depends on the available data and the 'cleaning' thereof
- Training an engine takes several days
- Two separate translation engines for each language pair are trained, e.g.:
 - English -> Danish
 - Danish -> English
- 254 new or upgraded engines in 2020

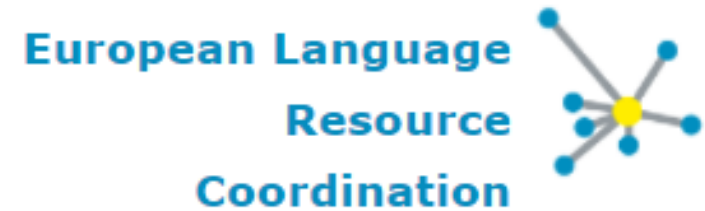

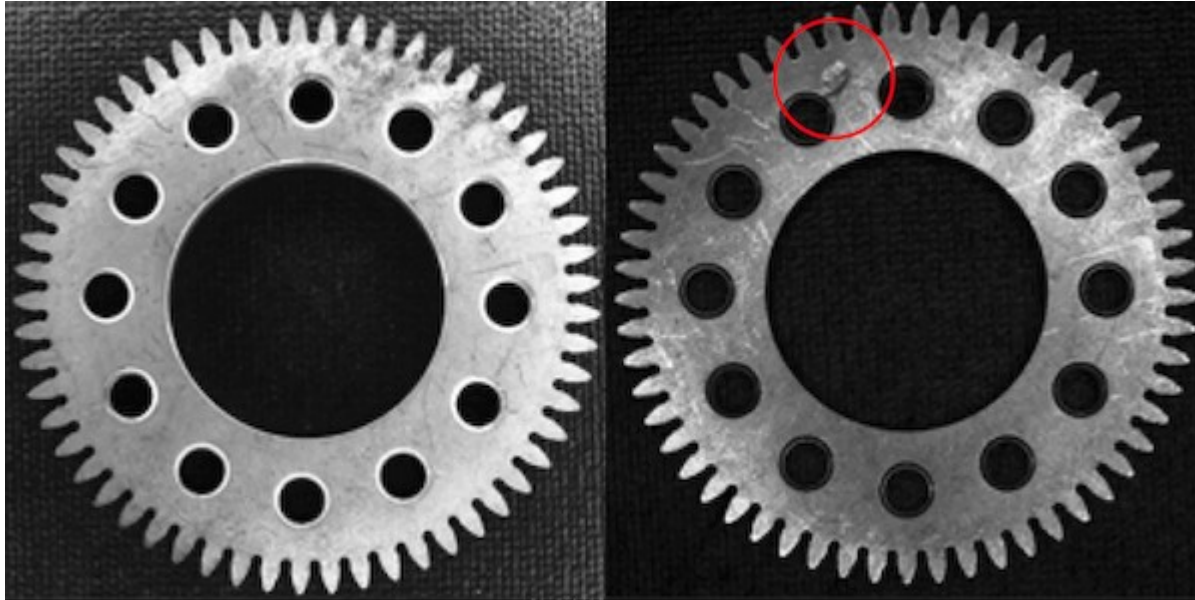

Quality data/data curation

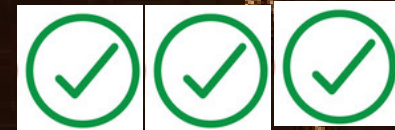

Whether photos or languages: Best results obtained with clear and correct data.

Legislative vs. general text

- General language: Several linguistically correct translations
- Legal language: Only one legally correct translation



In legislative documents

- quotes must be verbatim
- defined terms must be used consistently

Moreover, a legal act is often composed of bits and pieces from other legal acts (Regulations, Directives, Decisions, EU Treaty).

Consistent use of defined terms
